1. ACTION REQUIRED: ALEC STATION REQUESTS THAT THE IC PSYCHOLOGIST REMAIN AT [redacted] TO PROVIDE CONTINUED ASSISTANCE IN THE INTERROGATIONS OF ABU ZUBAYDAH (SUBJECT). Mitchell

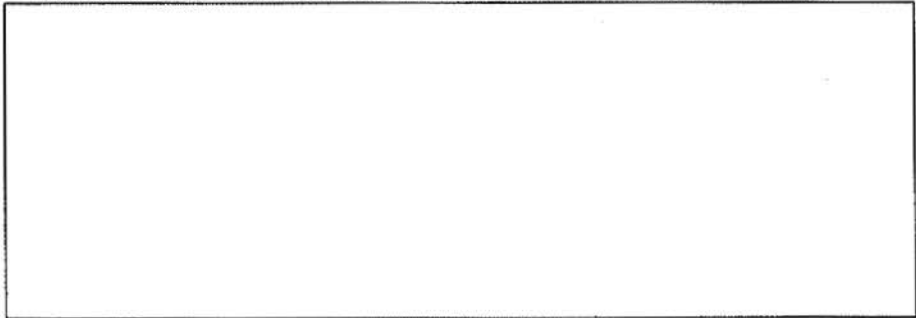
