RESULTS OF INTERVIEW WITH (b)(6),(b)(7)(C)

1. On 04Jan07, reporting agent (RA) responded to the Al Asad Surgical hospital, Al Asad Air Base, Iraq, regarding a detainee (V/ABDAL) from the Regional Detention Facility (RDF) who was brought into the hospital unconscious and unresponsive with Cardiopulmonary Resuscitation (CPR) in progress. Upon arrival at the hospital, RA was advised V/ABDAL had died. Subsequently, RA interviewed (b)(6),(b)(7)(C) (b)(6),(b)(7)(C) MC, 3rd Battalion 14th Marines, Golf Company, RDF, Al Asad, Iraq, regarding his knowledge of V/ABDAL's death.

2. (b)(6) advised he was in the barracks and heard (b)(6),(b)(7)(C) calling about getting people to HUMINT Exploitation Team (HET) compound, RDF, now (b)(6) indicated someone was getting (b)(6),(b)(7)(C) and as he was moving to the compound he ran into (b)(6),(b)(7)(C) stated he went into box four (4) (b)(6) reported he saw (b)(6),(b)(7)(C) assessing the detainee and he asked if there was a pulse and if he was breathing. (b)(6) related CPR was started by (b)(6),(b)(7)(C) and the following people were there around this time: (b)(6),(b)(7)(C) (b)(6),(b)(7)(C) he interpreter/TERP, (b)(6),(b)(7)(C) (HET), (b)(6),(b)(7)(C) (b)(6),(b)(7)(C) and (b)(6),(b)(7)(C) advised the detainees body was against the wall, with his arms to his side and his head was towards the door. (b)(6) stated the detainee's restraints were on at first then they were removed once the key arrived. (b)(6) advised he did not remember who took the handcuffs and leather belt off.

3. (b)(6) reported after a cycle of CPR he took over chest compressions on the detainee and he was not sure who swapped out on the breathing part from (b)(6),(b)(7)(C) stated there was rise and fall of the chest during the first check and he recalled there was slight moaning noise from the detainee. (b)(6) advised there was no pulse on the wrist and he was unsure if one was felt on the neck at this time. There was another switch of who performed compressions and breathing and (b)(6) advised at one point (b)(6),(b)(7)(C) and (b)(6),(b)(7)(C) participated (b)(6) recalled the doctor using the defibrillator pads and pressing the (b)(7)(C) button but it did not shock. (b)(6) explained the detainee was too hairy and the machine could not read correctly. (b)(6) estimated they were doing CPR for no more than six minutes prior to the fire department arriving on scene.

4. (b)(6) indicated the fire department attempted to use their Automatic External Defibrillator (AED) but were unsuccessful. (b)(6) stated he moved the desk (table) and the chair towards the back of the box when everyone was trying to move the detainee out. (b)(6) reported that he recalled (b)(6),(b)(7)(C) was standing in the corner behind the desk prior to the desk/table being moved. (b)(7)(E) and the computer were on the table at the time he moved it. (b)(6) advised he remembered there was a plastic chair in the corner but he

was unsure of where the cement block was located. According to (b)(6), (b)(7)(C) USMC, Commanding Officer, RDF, called to determine the arrival of an ambulance and was notified it would be another fifteen minutes. (b)(6) stated one emergency team, specifically the Southside flight line Emergency Medical Service, would not respond, although they are located down the street, due to the fact it was not their area of response. The detainee was then loaded into the highback HMMWV. (b)(6), (b)(7)(C) was straddling the detainee doing CPR.

5. (b)(6), (b)(7)(C) recalled that (b)(6), (b)(7)(C) notified higher ups within the chain of command about the incident. After the detainee left, (b)(6) reported (b)(6), (b)(7)(C) and himself cleaned up medical items within the box. (b)(6) stated they picked up three or four sets of pads, handed the Fire department their AED, wire snips, scissors, IV Bag, Oxygen tank, and the (b)(6), (b)(7)(E) took most of the medical gear. RA asked (b)(6) to draw the box area as he remembered it, enclosure (A) pertains. No further information was obtained at this time.

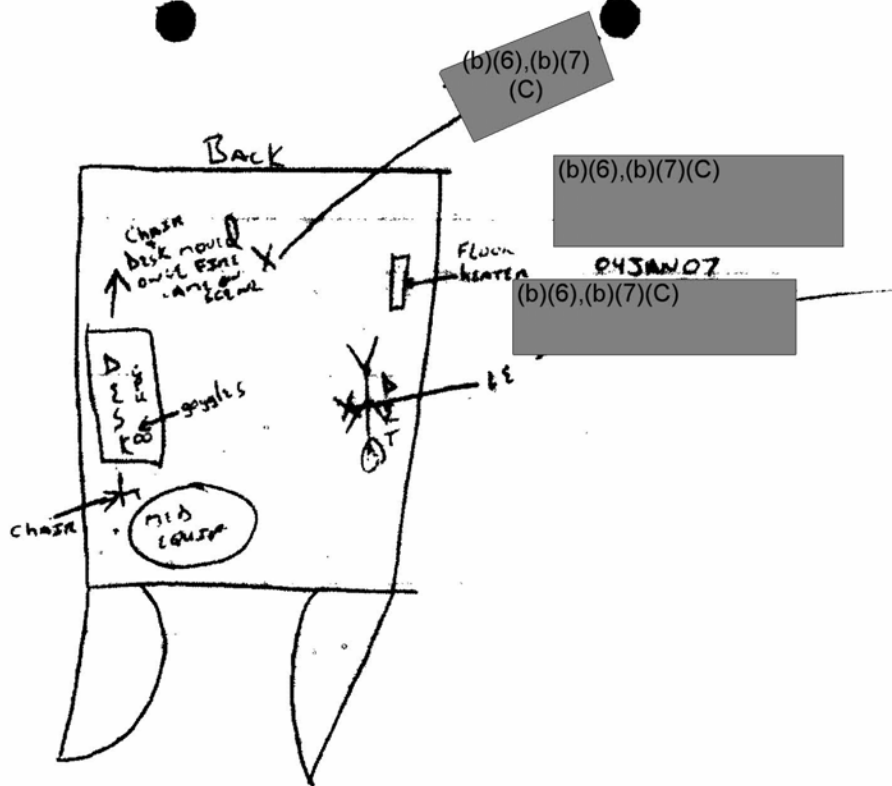

2. On 04Jan07, (b)(6),(b)(7)(C) advised RA that he had written a statement, on 03Jan07, regarding his knowledge of the detainee's death, enclosure (A) pertains. RA asked (b)(6),(b)(7)(C) to describe where the detainee was located upon his arrival on scene. (b)(6),(b)(7)(C) related the detainee was lying on his back near the right wall with his head towards the door. (b)(6),(b)(7)(C) reported the detainee had the leather belt on when he got there and someone (NFI) removed it during CPR. (b)(6),(b)(7)(C) stated he had no further information to add.
