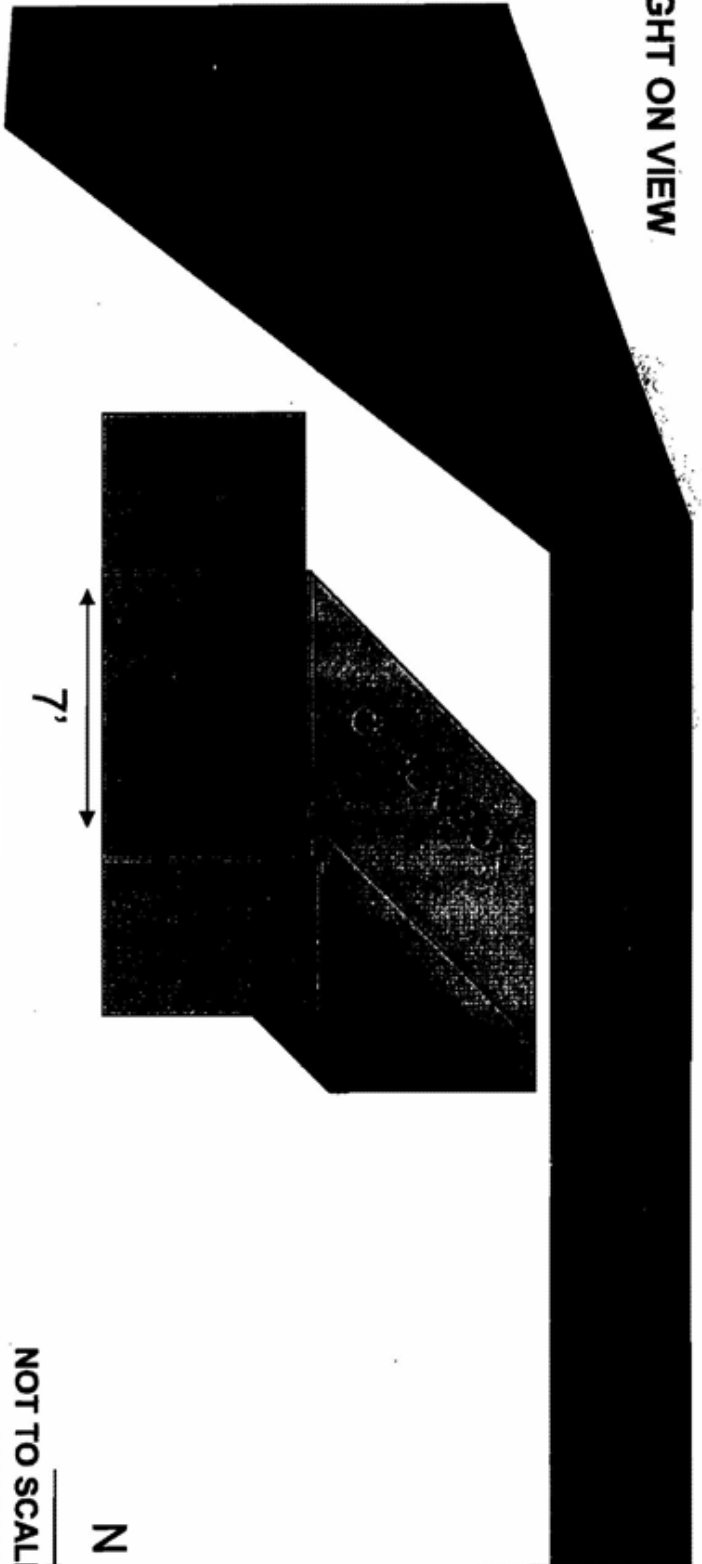
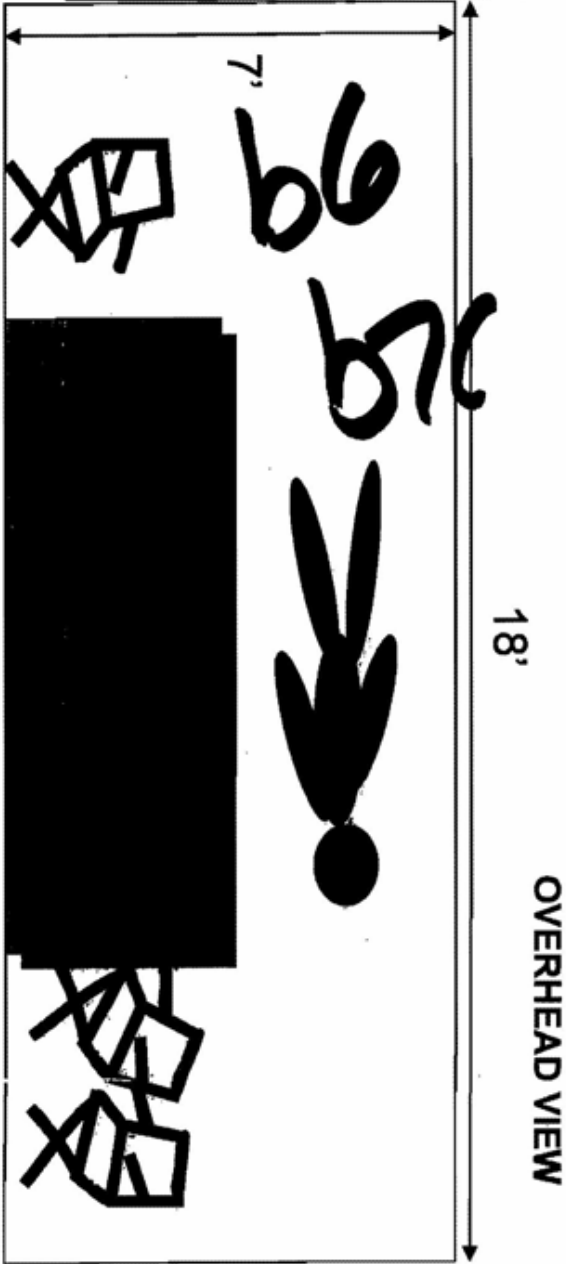
DEATH SCENE SKETCH

1. On 20Feb08, Reporting Agent (RA) took custody of a compact disc (CD) from (B)(6)(7C), USMC, at the Regional Detention Facility, Camp Al Asad, Iraq. The CD contains video footage of an interrogation of V/JABAR. During the interrogation, V/JABAR suffered an illness and subsequently died approximately 14 hours later at the Camp Al Asad hospital. The CD was entered into the NCISRA Iraq Evidence Custody System under log #021-08.
