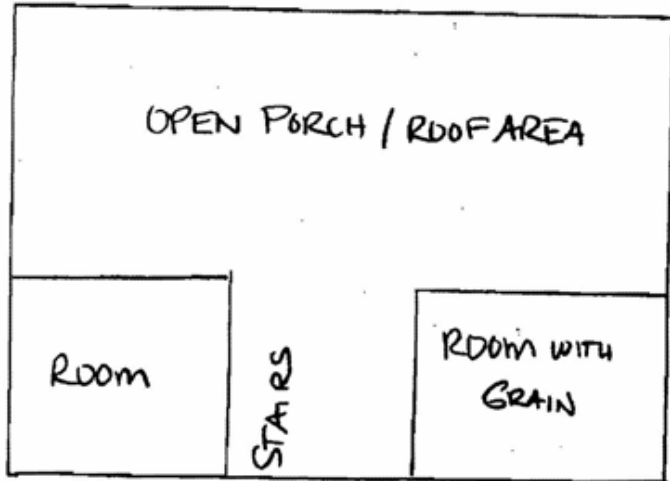

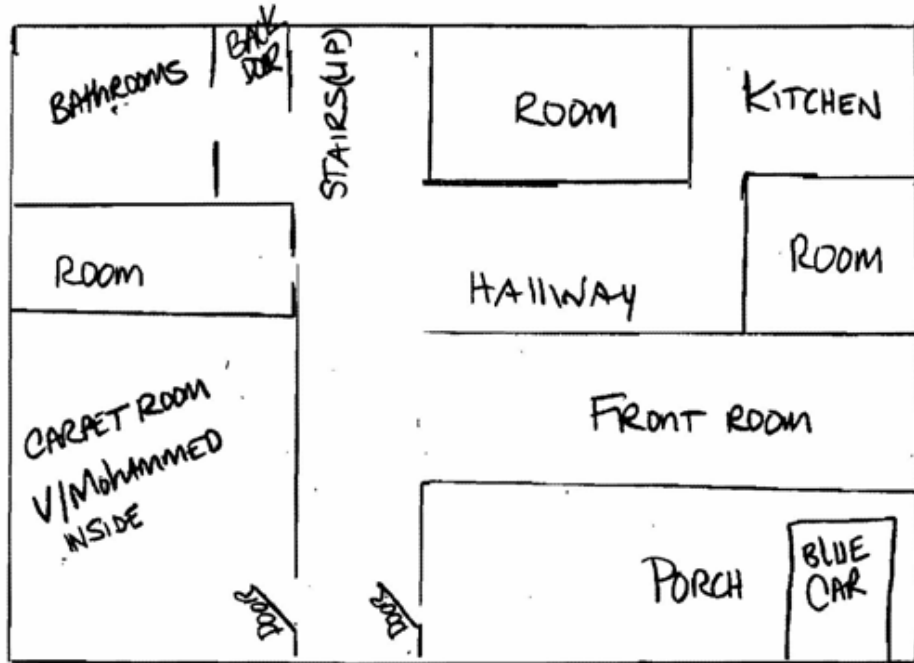

RESULTS OF RECEIPT OF TASK FORCE 88 STATEMENTS FROM (b)(6),(b)(7)(C)
(b)(6),(b)(7)(C) USAF

1. On 19Feb07, Reporting Agent (RA) received copies of command statements obtained from Task Force 88 members, regarding their knowledge of the death of V/MOHAMMED on 05Feb07, from (b)(6),(b)(7)(C) (b)(6),(b)(7)(C) USAF, Task Force 88, Judge Advocate. Upon review of the statements, RA requested interviews with each member and obtained additional sworn statements; which are reported under separate cover. Enclosures (A)-(J) pertain to command statements from (b)(6),(b)(7)(C) (b)(6),(b)(7)(C)

2. Statements indicate (b)(6),(b)(7)(C) was escorting V/MOHAMMED when he passed out and after assessment from (b)(6),(b)(7)(C), he was moved to an improvised litter (a ladder) and transported to the Landing Zone (LZ) where it was determined he expired. (b)(6),(b)(7)(C) made the decision to leave V/MOHAMMED on the LZ and requested local units to coordinate with Iraqi Police to facilitate V/MOHAMMED's body being returned to his family. RA requested and received permission to release the command statements as part of this investigation from (b)(6),(b)(7)(C) on 23Feb07.
