GUANTANAMO INVESTIGATION

- 1. Mission received the following communication from the five special rapporteurs who are conducting an investigation regarding the situation of detainees at Guantanamo (reftel). This communication has been forwarded to IO/SHA via e-mail and is included in number 10 on the Geneva 2005 Communications Log.
- 2. Begin text of letter:

8 August 2005

Excellency,

We have the honour to write to you in our respective capacities as Special Rapporteur on torture and other cruel, inhuman or degrading treatment or punishment, Chairperson-Rapporteur of the Working Group on Arbitrary Detention, Special Rapporteur on the right of everyone to the enjoyment of the highest attainable standard of physical and mental health, Special Rapporteur on the independence of judges and lawyers, and Special Rapporteur on freedom of religion or belief.

In our letter of 28 June 2005 we informed your Excellency's

Government that we intend to conduct of Indestination of the situation of detainees in Guantanamo Bay on the basis of reports from all credible sources and that we would inform you about our methods of work in due time. Further to that letter, please find attached a list of questions addressed to your Excellency's Government. We would be grateful to receive a response to these questions, along with any other relevant information your Government may wish to share.

As you are aware, the respective Commission on Human Rights resolutions establishing our mandates as well as Commission resolution 2004/76 on Human Rights and Special Procedures call upon all governments to cooperate with and assist mandate holders in the performance of their tasks and to supply all necessary information requested by them. In this regard we would like to reiterate that we consider the cooperation of your Government essential for the success of our investigation. For this reason we would appreciate it if the information is provided in a timely manner and is as comprehensive and detailed as possible.

Your Excellency will recall that in the "Joint Statement by participants at the eleventh Annual Meeting of the Special Rapporteurs/representatives, independent experts and chairpersons of the working groups of the Special Procedures of the Commission on Human Rights and of the Advisory Services Programme" of 30 June 2004 desire was expressed to visit 'those persons arrested, detained or tried on grounds of alleged terrorism or other violations, in Iraq, Afghanistan, the Guantanamo Bay military base and elsewhere".

Whereas this request was narrowed to a visit to Guantanamo Bay in the course of subsequent talks as your Government appeared to be available to consider a visit limited to the Guantanamo Bay military base, we re-iterate our interest in receiving information about all persons detained under US authority worldwide in the context of the "war on terror\*'. In particular, we wish to receive a complete list of all places of detention throughout the world where terrorism suspects are detained under US authority (including within US territory).

As stated previously, we would still very much welcome an invitation by your Government to visit Guantanamo Bay, and would incorporate the findings from our mission into our other investigations.

Please indicate their names, nationalities, date and place of arrest, dates of detention at Guantanamo, dates of release and to which country and/or under whose authority they have been released.
- 3. Please set forth the legal basis for the detention of the persons held at Guantanamo Bay. In this context, please elaborate on the applicability of international humanitarian law and/or of international human rights law to their detention.
- 4. How soon after their arrest have the detainees been given access to a lawyer?
- 5. Are the persons detained at Guantanamo Bay entitled to challenge their detention before a court and if so, have they been brought promptly before a judicial authority? What

is the basis for their right to chall to de AleSIF Telephtion or the basis for any limits on their right to do so?

- 6. Please describe the procedure applying to the review of their detention,
- 7. Have the detainees been promptly informed of the reasons for their arrest and detention and the charges brought against them? In what form and language?

  8. Have the families been notified of the detention and location of their relatives and the charges against them?
- 9. Do the detainees have the assistance of interpreters?
- 10. Have their embassies/consulates been notified? If so, were representatives of the diplomatic missions able to meet with their respective nationals?
- 11. How many of the persons detained at Guantanamo Bay are held in the framework of criminal proceedings? What law, substantive and procedural, governs such criminal proceedings? What stage are the criminal proceedings at in each individual case? What is the average time spent in detention since they have been charged by those detained in the framework of criminal proceedings?

- 12. Please describe conditions of detention in these places including information about incommunicado detention, periods of solitary confinement, periods of leisure activities, access to medical examinations and treatment, size of cells, etc.
- 13. What investigations of conditions of detention have been conducted? Please share the results with us.
- 14. Please indicate names of private firms authorised to manage places of detention and conduct interrogations?
- 15. Please provide details of the rules and procedures in place for ensuring confidentiality of medical records of detainees. In particular, please comment on the access of interrogators to medical records of detainees.
- 16. Please provide details on the number of suicide attempts and deaths by suicide among detainees.
- 17. How many of the detainees have died, for which reasons?

Please inform us about the outcome bandle investigations.

- 18. Please indicate which detainees were or currently are on hunger strike.
- 19. Are there any facilities offered to the detainees to practice their religious beliefs? Is there any space in the detention centre designed to serve as a place of worship or

## place for prayers?

- 20. Was the detainees9 diet prepared according to their needs and beliefs?
- 21. Do the detainees have access to members of the clergy or other religious practitioners or are they authorized to receive them in their place of detention? Are there any times set for prayers?
- 22. Do they receive or do they have access to the sacred texts of their religion?
- 23. Have there been any acts or declarations aimed at discrediting, insulting or humiliating the religious feelings of detainees or the detainees? If yes has there been any investigation and what have been the results of the investigations?
- 24. Is there any training or briefing provided to detention personnel with regard to religious beliefs of detainees?
- 25. Are there any specific internal regulations related to the religion of detainees in force at the places of detention?

- 28. Please provide comprehensive information about all
