IZ and AF Normal Death Rates

- **Overall Death Rate for Iraqi Citizens is 5.8 in 1,000 persons/year***
- **Overall Death Rate for Afghan Citizens is 17.1 in 1,000 persons/year***
- **Increased for in-custody status, expected death rates are:**
 - **7.0 in 1,000 Iraqi Prisoners**
 - **20.6 in 1,000 Afghani Prisoners**

Manner of Death Classifications

- Natural – Death due solely or nearly to disease and/or aging process**
- Accidental – Death with little or no evidence that injury occurred with intent to harm or cause death**
- Suicide – Death with evidence that injury or harm occurred as a result of intentional, self-inflicted act to cause harm or cause one's own death**
- Homicide – Death results from volitional act committed by another person to cause fear, harm or death. As used by medical examiners, it is a neutral term and neither indicates nor implies criminal intent**
- Undetermined – Used when information pointing to one manner of death is no more compelling than one or more other competing manner of death**

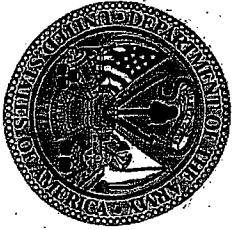

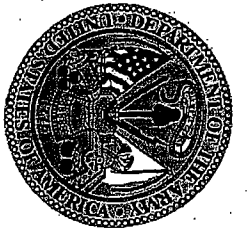

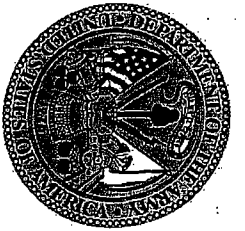
