About 1000, 11 Aug 04, this office was notified by Military Police Investigations (MPI), Office of the Provost Marshall, Fort Carson, CO 80913 (FCC), of an undetermined death of an Iraqi male who was killed in Iraqi by an American soldier. The Iraqi was in surrender status.

Investigation established probable cause to believe that the offense of Murder did not occur as alleged, in that SSG and the deceased Iraqi male was killed; however, he did not fire his weapon during the altercation.
