- 1. On 24 August 2003, I conducted a detention review for


 Task Force Ironhorse Central Detainee Facility. I have determined that continued detention is warranted.
- 2. After reviewing the relevant facts and the circumstances concerning and the detention and the detainee, I make the following factual determinations:
 - A. Mr. was in possession of an AK-47 and a RPG.
- B. There is probable cause to find that Mr. has committed a serious crime or is a threat to himself or the community.
 - C. Mr. is awaiting judicial proceedings for this serious crime.
- D. Continued confinement is necessary because less severe forms of restraint are inadequate and it is foreseeable that Mr. will not appear at trial, pretrial hearing or investigation or that he will commit a serious crime.
- 3. Based upon the relevant law and the above facts applied to that law, I find that continued detention is warranted in this case.
- 4. Determined this 24th day of August 2003.
