WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

The first was to process the detainee into the 1st ID detention facility and then check the detainee back out. The ODA then had the authority to hold the detainee for an additional 72 hours. This was rarely done and was never used with the intent to circumvent the 72-hour limitation. The second option the ODA had was to request an extension through the AOB. I only recall this being done once, by [redacted] for an Iraqi named [redacted]. The ODA made the request by sending a verbal or plain text which was sent via SATCOM. I then forwarded the request to [redacted]. The ODA received an affirmative response to the request. It was a very informal process and we did not have a specific form or format to use when making the request. It is possible that other requests to hold detainees over 72 hours were made, but I do not recall any. I never received any requests from [redacted]. Nothing follows.
