

This is an "Operation Iraqi Freedom" investigation.
On 11 Jul 04, this office reopened this investigation based on MR. providing a statement detailing he was assaulted by a black male.
Investigation established that SFC did not commit the offense of Assault, as initially alleged. Mr. Frelated he was never struck by SFC did not assault any detainees.
Further investigation established Mr. was not assaulted by any guards while detained at Camp Bucca, Iraq.







ABOUT 1110, 20 JUL 04, SA COORDINATED WITH CPT TRIAL COUNSEL, COMBINED FORCES LAND COMPONENT COMMAND (CFLCC), CAMP ARIFJAN, KUWAIT, WHO OPINED THERE WAS NOT PROBABLE CAUSE TO BELIEVE SFC OR PFC OR PFC OR PFC 676-4 COMMITTED THE OFFENSE OF ASSAULT, AS MR. STATED HE WAS NOT ASSAULTED BY A WHITE MALE AND THERE WERE NO MP OR MEDICAL RECORDS TO CORROBORATE THE ALLEGED INCIDENT. FURTHER MSG RENDERED STATEMENTS, WHICH WERE CONTRADICTORY, AND RELATED HE COULD NOT POSITIVELY IDENTIFY THE DETAINEE THAT WAS ALLEGED TO HAVE BEEN ASSAULTED. CPT FURTHER OPINED THERE WAS NOT PROBABLE CAUSE TO BELIEVE COMMITTED THE OFFENSE OF ASSAULT AS MSG STATEMENT SPECIFICALLY STATED SGT WAS NOT IN THE AREA DURING THE REPORTED INCIDENT, THERE WERE NO MP OR MEDICAL RECORDS TO CORROBORATE THE ALLEGED INCIDENT TOOK PLACE AND SGT !
