Investigation established probable cause to believe HABIB died as a result of a gunshot wound to the chest during a riot inside Ganci 3. Further, investigation established probable cause to believe GHAFAR died as a result of a gunshot wound to the head during the same incident.

16763,63 On 31 Aug 04, autopsies of HABIB and GHAFAR were performed by the Dr. (CDR) Armed Forces Institute of Pathology (AFIP), Rockville, MD. 





(If the suspect/accused says "yes," find out when and where If the request was recent (i.e., fewer than 30 days ago), obtain legal advice whether to continue the interrogation. If the suspect/accused says "no," or if the prior request was not recent, ask him/her the following question.)

"Do you want a lawyer at this time?"

(If the suspect/accused says "yes," stop the questioning until heishe has a lawyer. If the suspect/accused says "no." ask him/her the following question?

"At this time, are you willing to discuss the offense(s) under investigation and make a statement without talking to a lawyer and without having a lawyer present with you?" Iff the suspect/accused says "no" stop the interview and have him/her read and sign the non-waiver section of the waiver certificate on the other side of this form. If the suspect/accused says "yes," have him her read and sign the waiver section of the waiver certificate on the other side of this form.)

SPECIAL INSTRUCTIONS

WHEN SUSPECT/ACCUSED REFUSES TO SIGN WAIVER CERTIFICATE. If the suspect/accused orally waives his/her rights but refuses to sign the waiver certificate, you may proceed with the questioning. Make notations on the waiver certificate to the effect that he/she has stated that he/she understands his/her rights, does not want a lawyer, wants to discuss the offense(s) under investigation, and refuses to sign the waiver certificate.

If the waiver certificate cannot be completed at once, as in the case of street interrogation, completion may be temporarily postponed. Notes should be kept on the circumstances.

PRIOR INCRIMINATING STATEMENTS

1. If the supsect/accused has made spontaneous incriminating statements before being properly advised of his/her rights he/she should be told that such statements do not obligate him/her to answer further questions

2 If the suspect/accused was questioned as such either without being advised of his/her rights or some question exists as to the propriety of the first statement, the accused must be so advised. The office of the serving S aff Judge Advocate should be contacted for assistance in drafting the proper rights advisal.

NOTE If 1 or 2 applies, the fact that the suspect/accused vias acvised accordingly should be noted in the comment section on the vialuer certificate and initialed by the suspect/accused

WHEN SUSPECT/ACCUSED DISPLAYS INDECISION ON EXERCISING HIS OR HER RIGHTS DURING THE INTERROGATION PROCESS. If during the interrogation, the suspect displays indecision about requesting counsel for example, "Maybe I should get a lawyer") further questioning must cease immediately. At that point, you may question the suspect accused only concerning whether he or she desires to waive counsel. The questioning may not be utilized to discourage a suspect/accused from exercising his her rights. For example, do not make such comments as "If you didn't do anything viring withing shouldn't need an attorney.")



The detainees were identified as: Believed to be (BTB) HABIB, Fras Moazahim ISN 156860 BTB Ghafar, Nafit Husham ISN 160915-Detainee HABIB's autopsy revealed he suffered a penetrating shotgun wound of the chest, perforating shotgun wound of the right upper back, perforating shotgun wound of the right arm and a perforating shotgun wound of the left arm. The wound to the chest involved both lungs and the heart. A single metallic projectile was recovered in the right upper chest. No evidence of significant natural disease was noted during the autopsy. Based on the direction of travel it was determined Detainee HABIB was very likely facing away from the direction of fire when he was shot. Detainee GHAFAR's autopsy revealed he suffered a penetrating shotgun wound of the head. The entrance wound was located in the right side rear of the head. The wound involved a large portion of the right side of the brain. A single metallic projectile was recovered from within the skull. Based on the direction of travel it was determined Detainee GHAFAR was very likely facing away from the direction of fire when he was shot. Additionally, based on the deformation of the projectile, it seems likely the projectile struck an intermediate target prior to striking Detainee GHAFAR. No evidence of significant natural disease was noted during the autopsy. On 30 Aug 04, the undersigned obtained copies of the Preliminary Autopsy Diagnosis, photographs and Death Certificates pertaining to the two autopsies. 
