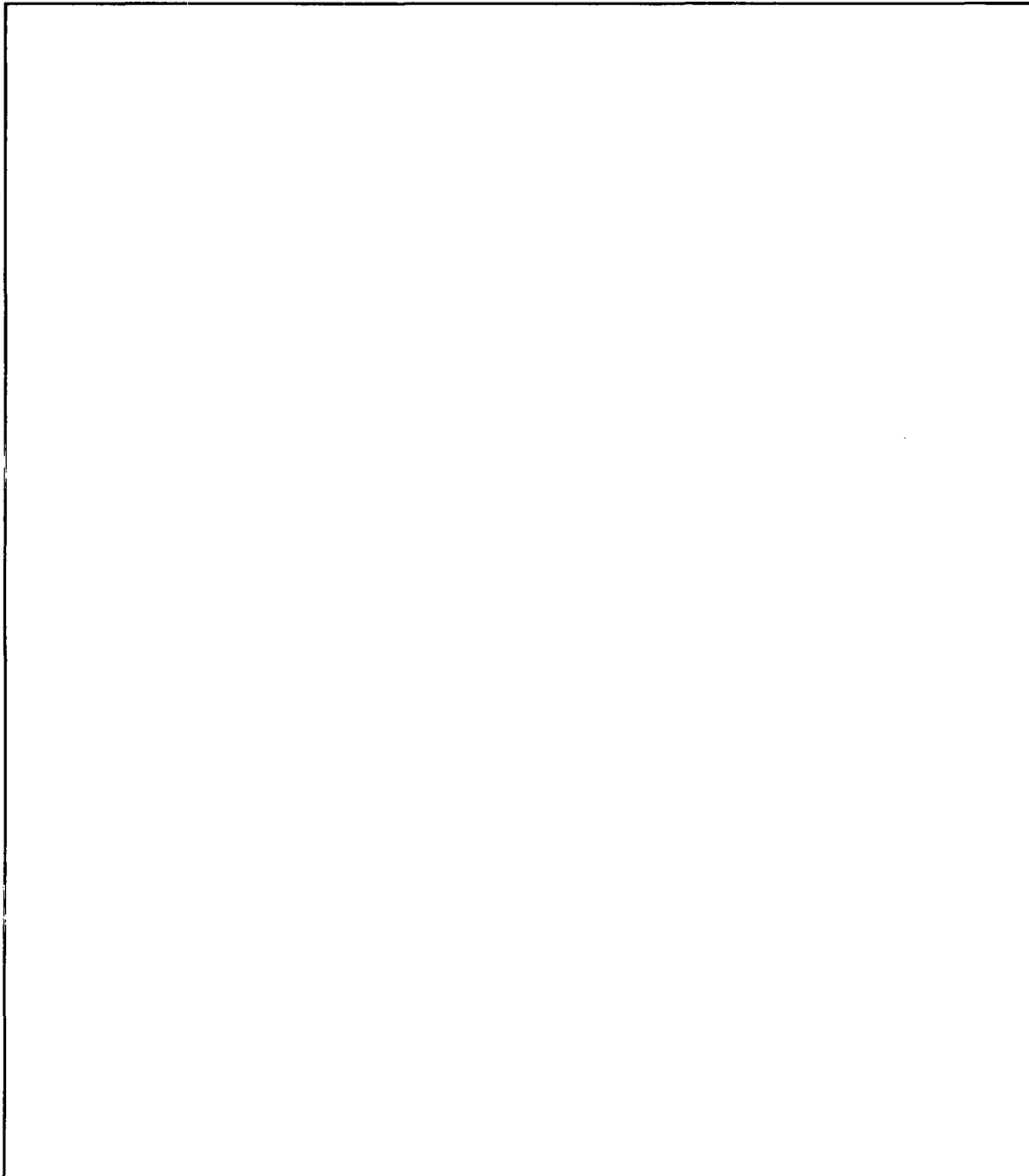

leader Shaikh Salah Fuad Ubaid. Ubaid posited that the US Army abused Arab prisoners at GTMO because President Bush waged war against Arabs and the Muslim world. On the same day, independent newspaper "Al Wasat" reported that Bahrain Human Rights Society Deputy Secretary General Salman Kamal Al-Din questioned the credibility of the torture. He noted that a GOB security delegation recently visited Guantanamo and confirmed that the detainees were in good physical and mental condition.
