(C) IN A 10/20 MEETING AT THE MFA, DCM INFORMED MFA AMERICAS DESK DIRECTOR [REDACTED] OF USG WILLINGNESS TO CONSIDER A FORMAL REQUEST BY THE [REDACTED] TO SEND A DELEGATION TO GUANTANAMO BAY, CUBA TO CONDUCT INTERVIEWS OF ITS NATIONALS. SHE SHARED WITH [REDACTED] SPECIFIC GUIDANCE INCLUDED IN REFTEL A AND NOTED EXISTING COORDINATION ON THIS ISSUE BETWEEN U.S. OFFICIALS AND MEMBERS OF THE [REDACTED]

2. (C) [REDACTED] THANKED DCM FOR THE INFORMATION BUT INDICATED THAT THE GOS DID NOT HAVE A FULL LIST OF THE NAMES OF ALL ITS NATIONALS DETAINED AT GUANTANAMO. HE ASKED THAT THE USG PROVIDE SUCH A LIST AS SOON AS POSSIBLE. DCM STATED THAT SHE WOULD CONVEY HIS REQUEST TO THE DEPARTMENT OF STATE.
