I understand that in [redacted] meeting in NY yesterday with [redacted] the latter argued in response to our TPs that the detainee should be considered a POW and have his status adjudicated by a military tribunal. He also challenged group over individual determinations of enemy combatant status. [redacted] is writing up the conversation and will share, but the dialog seems now to be taking a more legal turn. Below is an advance copy of a cable being sent today from [redacted] reporting a parallel discussion there.
