BUT SHE ALSO EMPHASIZED THAT THERE HAVE BEEN SIGNIFICANT INDICATIONS PROGRESS BY THE GOB SINCE HER VISIT IN MAY 2000, THE MOST PROMINENT OF WHICH WAS UNCLASSIFIED

RESPONDING TO ANOTHER QUESTION, SHE SAID THAT AS HIGH COMMISSIONER SHE IS DUTY-BOUND TO SPEAK OUT ON SITUATIONS SUCH AS CAMP X-RAY, AND THAT IT IS AN HONOR TO DEFEND THOSE WHO HAVE NO OTHER VOICE.
