-- WE CONTINUE TO PREPARE FOR THE QUARTET THE SECRETARY IS HOSTING HERE AT THE DEPARTMENT TODAY, AND OUR FOCUS REMAINS ON MOVING FORWARD IN A WAY THAT MAKES POSSIBLE IMPLEMENTATION OF THE PRESIDENT'S JUNE 24TH VISION OF TWO STATES - ISRAEL AND PALESTINE - LIVING SIDE-BY-SIDE IN PEACE AND SECURITY. -- WE ARE DEEPLY TROUBLED BY UPSURGE IN VIOLENCE IN THE REGION, INCLUDING THE KILLING OF AN 11-YEAR OLD PALESTINIAN GIRL IN GAZA YESTERDAY AND THE KILLING BY GUNMEN OF A RABBI IN GAZA EARLIER TODAY. -- THE USG WILL BE HAPPY TO CONSIDER ANY APPLICATION FOR A VISA TO VISIT THE U.S., AND WILL MAKE ITS DECISION BASED ON THE LEGAL CRITERIA FOR ISSUANCE OF NON-IMMIGRANT VISAS.

Q: IF TRAVEL TO GUANTANAMO IS NOT POSSIBLE, AND THAT IS THEIR REASON FOR GOING TO THE U.S., WOULD THE APPLICANTS STILL BE ELIGIBLE FOR VISIT VISAS?

-- WE CANNOT PRE-ADJUDICATE THESE APPLICATIONS NOW. THEY WILL RECEIVE VISAS TO VISIT THE UNITED STATES IF THE CONSULAR OFFICER FINDS THEM ELIGIBLE UNDER U.S. LAW.

Q: DON'T THE <<DETAINEES>> HAVE THE RIGHT TO SPEAK WITH A LAWYER?

-- IN THIS WAR, AS IN EVERY WAR, ENEMY COMBATANTS HAVE NO RIGHT TO COUNSEL OR ACCESS TO COURTS FOR THE PURPOSE OF CHALLENGING THEIR DETENTION.

-- ACCESS TO COUNSEL, IN THE ABSENCE OF CRIMINAL CHARGES, BY ENEMY COMBATANTS WOULD DIRECTLY INTERFERE WITH OUR SECURITY INTERESTS AND THE ONGOING EFFORTS OF THE UNITED STATES AND ITS COALITION PARTNERS TO GATHER AND EVALUATE INTELLIGENCE ABOUT THE ENEMY, ITS CAPABILITIES, AND ITS PLANS.

-- IF A <**CETAINEE**>> IS CHARGED WITH A CRIME, THE INDIVIDUAL WOULD HAVE ACCESS TO COUNSEL AND WOULD RECEIVE A FAIR TRIAL.

-- TO DATE, NO ENEMY COMBATANT AT GUANTANAMO HAS BEEN CHARGED WITH A CRIME.
