1) ISRAEL/PALESTINIANS: ROADMAP PROGRESS

KEY POINTS:

-- WE ARE THOROUGHLY ENGAGED IN FOLLOW-UP TO THE DISCUSSIONS PRESIDENT BUSH HAD WITH PRIME MINISTER SHARON JULY 29 AND WITH PRIME MINISTER ABBAS JULY 25.

-- AMBASSADOR WOLF WILL RETURN TO THE REGION TODAY TO CONTINUE MONITORING AND COORDINATING STEPS TO FULFILL THE COMMITMENTS BOTH PARTIES MADE TO PRESIDENT BUSH; AMBASSADOR KURTZER AND ACTING CONSUL GENERAL JEFF FELTMAN CONTINUE ACTIVE DISCUSSIONS WITH BOTH SIDES. SECRETARY POWELL, NATIONAL SECURITY ADVISOR RICE, AND ASSISTANT SECRETARY OF

NEAR EASTERN AFFAIRS WILLIAM J. BURNS, ARE IN REGULAR CONTACT WITH THE PARTIES.

-- BOTH SIDES HAVE OBLIGATIONS. BOTH SIDES HAVE RESPONSIBILITIES. THE SUBSTANCE OF THESE OBLIGATIONS AND RESPONSIBILITIES HAS NOT CHANGED. ALL PARTIES AGREE THAT A FUNDAMENTAL IMPEDIMENT TO PROGRESS IS TERRORISM.

KEY POINTS:

-- AS THE SECRETARY NOTED YESTERDAY, THERE ARE SOME VERY POSITIVE DEVELOPMENTS IN IRAQ: "IRAQI REFUGEES RETURNED TO THEIR HOMELAND TODAY FROM SAUDI ARABIA OUT OF REFUGEE CAMPS FOR THE FIRST TIME IN 12 YEARS, AND THE JOY IS CLEAR IN THEIR FACES THAT THEY ARE ABLE TO GO HOME." WE ARE WORKING TO ENSURE THAT THE SECURITY AND INFRASTRUCTURE EXISTS TO PERMIT THE SAFE RETURN OF THE MANY THOUSANDS OF IRAQI REFUGEES WHO FLED THE SADDAM HUSSEIN REGIME AND WILL CONTINUE TO CONSULT

CLOSELY WITH UNHCR AND IRAQ, S NEIGHBORS AS WE MOVE FORWARD. ((I MADE THIS CHANGE BECAUSE I KNOW THAT WE DON, T WANT LARGE-SCALE RETURNS YET))

-- AS YOU KNOW, THE GOVERNING COUNCIL HAS ELECTED A PRESIDENCY FOR ITSELF; AN IMPORTANT FIRST STEP AS THE COUNCIL ORGANIZES ITSELF FOR THE CHALLENGING WORK AHEAD. THE GOVERNING COUNCIL WILL NAME MINISTERS, OVERSEE IRAQI MINISTRIES AND THE PREPARATION OF THE 2004 BUDGET, AND HELP LAUNCH A CONSTITUTIONAL PROCESS THAT WILL DRAFT A NEW IRAQI CONSTITUTION AND PAVE THE WAY FOR NEW ELECTIONS.

-- THERE ARE OVER 12,000 IRAQI POLICEMEN BACK ON THE STREETS IN BAGHDAD, AND THIS MEANS A VISIBLE IRAQI PRESENCE INVOLVED IN MAINTAINING SECURITY. IN THE NEXT TWO MONTHS, WE WILL RECRUIT AND TRAIN THE FIRST BATTALION OF THE NEW IRAQI ARMY AS A VOLUNTEER) (NOT A CONSCRIPTION) - FORCE. ELECTRICITY OUTPUT IS UP TO 74% OF PRE-WAR OUTPUT AND WE HAVE A NUMBER OF DEVELOPMENT PROJECTS UNDERWAY THAT WILL GET US BACK UP TO MEETING IRAQ'S ELECTRICITY NEEDS. OVER 90% OF IRAQI PUBLIC SCHOOLS HAVE RE-OPENED AND ALL 22 IRAQI UNIVERSITIES HAVE RE-OPENED. IN ADDITION, QATAR AND UNESCO HAVE JOINTLY CREATED AN IRAQI HIGHER EDUCATION FUND WITH AN INITIAL \$15 MILLION QATARI CONTRIBUTION TO ENHANCE IRAQI HIGHER EDUCATION PROGRAMS IN INFORMATION TECHNOLOGY,

NEW IRAQI GOVERNOR.

-- THE COALITION EFFORT IS TRULY INTERNATIONAL AND PROGRESS IS BEING MADE, AND AS THE SECRETARY NOTED, "THERE ARE A LOT OF GOOD THINGS THAT ARE HAPPENING (AND) SLOWLY BUT SURELY, AMBASSADOR BREMER AND HIS TEAM ARE SUCCESSFULLY STARTING UP ECONOMIC ACTIVITY AND A POLITICAL PROCESS IS UNDERWAY. THE INTERNATIONAL COMMUNITY IS COMING IN ALL WAYS TO SUPPORT THIS EFFORT."

REGARDING AMNESTY INTERNATIONAL CRITICISMS:

-- WE ARE LOOKING AT THE AMNESTY INTERNATIONAL REPORT. I WOULD REITERATE THAT THE COALITION IS VERY FOCUSED ON ENSURING THAT THE SITUATION INSIDE IRAQ CREATED BY THE REGIME OF SADDAM HUSSEIN AND INHERITED BY THE COALITION IS RECTIFIED AS QUICKLY AS POSSIBLE. WE HAVE LONG DOCUMENTED THE DEPLORABLE HUMAN RIGHTS SITUATION IN IRAQ UNDER SADDAM HUSSEIN, INCLUDING THE DISCREDITED AND LARGELY DYSFUNCTIONAL JUDICIAL SYSTEM, A NON-FUNCTIONING POLICE FORCE, THE RELEASE OF TENS OF THOUSANDS OF VIOLENT CRIMINALS ONTO THE STREETS IN THE LATE DAYS OF THE REGIME, THE PERVASIVE CLIMATE OF FEAR AND REPRESSION, AND THE ABSENCE OF THE RULE OF LAW.

-- WE ARE WORKING AS QUICKLY AS POSSIBLE TO ADDRESS THIS. MANY OF THE STEPS I HAVE PREVIOUSLY MENTIONED - THE TRAINING OF A NEW POLICE FORCE AND CIVIL DEFENSE FORCE, THE RE-OPENING OF THE CRIMINAL COURTS AND THE RESUMPTION OF CRIMINAL TRIALS WILL HELP SIGNIFICANTLY ADDRESS THE ISSUES NOTED IN THE AMNESTY INTERNATIONAL REPORT.

-- WHILE A GREAT DEAL OF WORK REMAINS TO BE DONE, THERE HAVE BEEN SIGNIFICANT ACHIEVEMENTS TO DATE, AND WE BELIEVE THE HUMAN RIGHTS SITUATION IN IRAQ IS STEADILY IMPROVING.

(IF PRESSED ON DETAINEES):

-- AS AMBASSADOR BREMER SAID WHILE IN WASHINGTON: &WE ARE IN FULL COMPLIANCE WITH OUR OBLIGATIONS UNDER THE GENEVA CONVENTIONS. THE ICRC, THE UNHCR, THEY ALL HAVE FULL ACCESS AND HAVE VISITED OUR DETAINEES. OUR DETAINEES NOW HAVE ACCESS TO LAWYERS. WE HAVE ARRANGED FAMILY VISITS FOR ALL BUT A FEW OF THE DETAINEES.

BACKGROUND FOR BRIEFER ONLY: IN LATE MAY, THE SECRETARY-GENERAL FORWARDED THE BAKER PEACE PLAN IN A REPORT TO THE UNSC. SECURITY COUNCIL CONSULTATIONS BEGAN WITH THE ANNOUNCEMENT THAT THE POLISARIO HAD ACCEPTED THE PLAN. THE US CIRCULATED A DRAFT MINURSO RESOLUTION THAT HAD BEEN DISCUSSED BY THE FRIENDS GROUP. AFTER SEVERAL WEEKS OF DISCUSSION AND A LENGTHY SESSION YESTERDAY, THE COUNCIL WAS ABLE TO REACH CONSENSUS ON A SLIGHTLY MODIFIED TEXT. THE TEXT WAS VOTED ON THIS MORNING; UNSCR 1495 PASSED UNANIMOUSLY.

PRIOR TO YESTERDAY, S COUNCIL SESSION, MOROCCO ISSUED A STATEMENT REJECTING THE BAKER PLAN. IT IS UNCLEAR, HOWEVER, WHETHER MOROCCO, S POSITION HAS CHANGED DUE TO THE COURSE OF EVENTS OF THAT SESSION. POWELL
