Camp Ganci, IZ.

The conduct of this investigation determined that a Report of Investigation (0010-04-CID789),
was previously submitted by the Baghdad Central Confinement Facility (BCCF), to document the
death of Mr. ABU NASSER.

"THIS IS AN OPERATION IRAQI FREEDOM INVESTIGATION"

THIS OFFICE WAS NOTIFIED BY THE OPERATIONS OFFICER, 391ST MILITARY POLICE (MP) BATTALION (BN), BAGHDAD CORRECTIONAL CONFINEMENT FACILITY (BCCF), ABU GHRUYEB, IRAQ, OF A MORTAR ATTACK AT THE BCCF WHICH RESULTED IN THE DEATHS OF NINE DETAINEES.

PRELIMINARY INVESTIGATION REVEALED ELEVEN MORTAR ROUNDS WERE FIRED FROM AN UNKNOWN LOCATION OUTSIDE OF THE PERIMETER AND LANDED IN GANCI "6" HOLDING YARD, WHICH KILLED DETAINEES ABU NASSER, PRONOUNCED DECEASED AT 1910, 6 APR 04; GAER, PRONOUNCED DECEASED AT 1912; SHAHAB, PRONOUNCED DECEASED AT 1913, 6 APR 04; M. JASSEM, PRONOUNCED DECEASED AT 1916, 6 APR 04; JASSIM, PRONOUNCED DECEASED AT 1919, 6 APR 04; N. JASSEM, PRONOUNCED DECEASED AT 1920, 6 APR 04; MASHNADANE, PRONOUNCED DECEASED AT 1923, 6 APR 04; A. SHAHAB, PRONOUNCED DECEASED AT 1924, 6 APR 04 AND AN UNIDENTIFIED DETAINEE. THE ABOVE DETAINEES SUSTAINED MULTIPLE BLAST AND SCHRAPNEL INJURIES AND WERE PRONOUNCED DECEASED BY 1LT (DR.) [REDACTED] 391ST MP *b7c-3, b6-3*
BN, ABU GHRUYEB, IRAQ.

DETAILS

BASIS OF INVESTIGATION: On 6 Apr 04, this office was notified by the 391st Military Police (MP) Battalion (BN), Abu Ghryeb, Iraq (AGI), of a mortar attack at Abu Ghryeb Prison which killed Detainees ABU NASSER, Hasan Hamad, National Detainee Reporting System (NDRS) #116662; GAER, Ahmed Selfeegi, NDRS #152559; SHAHAB, Ismael Abdulhusein, NDRS #155043; JASSEM, Khudair Museif, NDRS #159026; JASSIM, Awad Salih, NDRS #157380; AHMED, Ibrahim Ismael, NDRS #151443; JASSEM, Khalaf Najif, NDRS #159027; MASHNADANE, Karim Ibrahim, NDRS #115872; and SHAHAB, Andan Abdulhussien, NDRS #155044.

About 0800, 7 Apr 04, SA [redacted] ^{b7c-1 b6-1} coordinated with the Abu Ghryeb Prison In-processing Office and obtained dossiers for Detainees ABU NASSER, GAER, I. SHAHAB, M. JASSEM, AHMED, JASSIM, N. JASSEM, MASHNADANE, AND A. SHAHAB.

About 0815, 7 Apr 04, SA [redacted] ^{b7c-1 b6-1} coordinated with 391st MP BN operations and obtained the Serious Incident Report (SIR). (See SIR)

About 0830, 7 Apr 04, SA [redacted] ^{b7c-1 b6-1} coordinated with 1LT (Dr.) [redacted] ^{b7c-3 b6-3} 391st MP BN Medical Team, AGI, and obtained the death certificates for ABU NASSER, GAER, I. SHAHAB, M. JASSEM, AHMED, JASSIM, N. JASSEM, MASHNADANE, AND A. SHAHAB. (See Death Certificates)

About 1800, 7 Apr 04, SA [redacted] ^{b7c-1 b6-1} was notified by SGT [redacted] ^{b7c-1 b6-1} 391st MP BN, Prisoner In-Processing Section, AGI, that Detainee AHMED (#151443) was not deceased and his office was working to identify the unknown detainee.

About 0800, 8 Apr 04, SA [redacted] ^{b7c-1 b6-1} coordinated with SFC [redacted] ^{b7c-1 b6-1} 391st MP BN, Prisoner In-Processing Section, AGI, who stated he would not be able to determine the identity of the detainee until all detainees return from the CSH. He stated over 70 detainees were treated by the CSH and not all detainees could be identified. He said it could take several days or weeks.

INITIATE AN INVESTIGATION REGARDING THE DEATH OF MR. MASHNADANE, WHO DIED WHILE IN UNITED STATES CUSTODY AT CAMP GANCI, IZ.

PRELIMINARY INVESTIGATION REVEALED MR. MASHNADANE WAS CAPTURED ON 3 JUL 03 AND WAS CONFINED AT BAGHDAD CENTRAL CONFINEMENT FACILITY, ABU GHRAIB, IZ (BCCF) ON 16 AUG 03. A REVIEW OF THE "PMO DETAINEE NOT IN CAMP ROSTER" BY USACIDC, DISCLOSED MR. MASHNADANE WAS LISTED AS DECEASED.

A REVIEW OF MR. MASHNADANE'S DETAINEE FILE DISCLOSED HE UNDERWENT A MEDICAL SCREENING ON 13 JUL 03, WHICH REFLECTED HE WAS TAKING MEDICATION FOR HEADACHES, BUT DID NOT DISCLOSE THE TYPE OF MEDICATION. FURTHER, THE MEDICAL SCREENING DID NOT DISCLOSE ANY SIGNS OR SYMPTOMS OF INJURY OR ILLNESS.

THIS REVIEW FURTHER DISCLOSED A LEGAL REVIEW OF MR. MASHNADANE'S DETAINEE FILES WAS CONDUCTED ON 20 JAN 04, WHICH RECOMMENDED MR. MASHNADANE'S RELEASE.

AT THIS TIME, IT IS UNKNOWN IF ANY MEDICAL CONDITIONS DEVELOPED DURING MR. MASHNADANE'S CONFINEMENT, WHICH COULD HAVE CONTRIBUTED TO HIS DEATH; IF MR. MASHNADANE WAS TAKING ANY MEDICATIONS WHICH MAY HAVE CONTRIBUTED TO HIS DEATH; IF RESUSCITATION EFFORTS WERE TAKEN; OR IF MR. MASHNADANE UNDERWENT A FORENSIC AUTOPSY.
