[redacted] I met with [redacted] and [redacted] today about the issues raised in your email (I was on annual leave yesterday afternoon). [redacted] has requested the FOIA unit in RMD to compare the material gathered for the IG with the material identified and processed under FOIA. If we find additional records that come within the FOIA search parameters, they will be processed and accounted for in the FOIA litigation as a group. After this review and coordination, there should be little risk that future detainee searches will need to be compared with the FOIA search, since it is time limited (ie. those records that were in existence on the FOIA request cutoff date).
